16) Discuss and consider authorizing Interim General Manager, Rene Flores, Investment Officer, to invest *Texas Regional Bank and Rio Bank* funds to Certificate of Deposits governed by Subchapter A, Chapter 2256, and Government Code Public Funds Investment Act. (Doc. No. 20-R036)

Interim General Manager informed Board Members that in light of the pandemic crisis and extremely low interest rates, Texas Regional Bank offered a rate of .55% APY 3 month term on the 4 (four) CD's which matured April 19, 2020. Once CD's mature in July 2020, they can be renewed another 3-6 months. Mr. Santana Gutierrez made a motion and seconded by Mr. Brandon Thompson to approve Interim General Manager, Rene Flores, Investment Officer, to invest *Texas Regional Bank and Rio Bank* funds to Certificate of Deposits governed by Subchapter A, Chapter 2256, and Government Code Public Funds Investment Act.
